For catering purposes, confirmation of total numbers and any dietary requirements are required five working days prior to the event. The confirmed number provided is what your final account will be based on.

### **Tentative booking Policy:**

Tentative bookings are held for a period of seven days only, after which a \$200 deposit is required. A full refund is available up to 7 days prior to event. Grants on Sherbrooke hold the right to cancel unconfirmed bookings without notice after the seven day period has lapsed.

### **Décor:**

You are more than welcome to decorate the room on the day of the function, provided there are no prior bookings. A time will be allocated as to when the room will be available. Please phone 24 hours beforehand to confirm this option. Nothing is to be nailed, stapled or screwed into any wall or other surfaces of the building.

### **Music and Entertainment:**

Entertainment will be subject to approval. Management must be advised at the time of the booking. Music can be played until 11.15am or as otherwise approved.

### **Surcharge:**

Grants on Sherbrooke is available as a private function area for a five hour duration. Additional time incurs a fee of \$400 per hour for evening functions past 11.30pm.

It is the organisers responsibility to make sure their guests have completely vacated the premises by 11.45pm

### **Property damage:**

Organisers are 100% financially responsible for all damages or theft caused to any area of Grants on Sherbrooke Picnic Ground and building by their guests, delegates or agents, before, during and after a function

### **Responsibility:**

Grants on Sherbrooke does not accept responsibility for damage or loss of any guest's property. This applies to all areas of Grants Picnic Ground

### **Liquor Licensing Requirements:**

No alcoholic beverages are permitted at any time to be brought onto the premise by the guests.
